### PRICES

Package prices are based on a per person twin share and maybe subject to change.

A deposit of AUD \$1000 is requested at booking. A receipt will be provided.

### CANCELLATIONS/REFUNDS

This deposit is 50% refundable until 1<sup>st</sup> January 2025. After this all deposits are non-refundable Full payment is required by 26th February 2025. Payments can be made in installments. Cancellation of booking after the 1<sup>st</sup> January 2025 less the deposit is fully refundable until 60 days prior to tour commences, 26th February 2025. From this date the tour is 100% non-refundable. All visits, excursions, meals non utilized are non-refundable.

#### **EXTRA INFORMATION**

Seat belts must be worn at all times in mini bus while travelling with France & Beyond Tour leader.
